

# Rules and Regulations of School for Startups Romania 2012 Competition

Rules and Regulations of School for Startups Romania Competition

## 1. COMPETITION ORGANIZER

School for Startups Romania 2012 competition is organized by Post-Privatization Foundation, having its registered office at at 46-48, Calea Plevnei, Buildings A and B, 1st and 2nd floors, Sector 1, Bucharest, Romania.

The participants are required to comply with the terms and conditions of the official regulations of the competition, in accordance with aspects mentioned below (hereinafter called „Official Regulations"). The provisions of the official regulations of the Competition are accepted when registering in the Competition by observing the conditions of participation.

The Official Regulations will be drafted and made public under the laws applicable in Romania by publishing under the tab School for Startups Romania 2012 Competition on the official Facebook account of School for Startups Romania throughout the Competition according to details mentioned in Section 2. The organizer reserves the right to modify or change the Official Regulations; such changes will take effect only after the notice of presentation of these changes under the tab School for Startups Romania 2012 Competition on the official Facebook account of School for Startups Romania.

## 2. TIME AND PLACE OF THE COMPETITION

The competition is organized and conducted throughout Romania under the provisions of the Official Regulations and will start on November 7, 2011 and end on January 7, 2011. The contest will be constantly promoted on the official channels School for Startups Romania.

The name of the winner will be made public on <http://www.facebook.com/s4sromania> on January 16, 2011. The organizer reserves the right to change the date when the winner should be selected, with prior notice, maintaining the number and the value of the prize originally announced.

In the event where the winner cannot be contacted or refuses to accept the prize, the participant ranked second, in descending order of their score, will be contacted. If the latter cannot be contacted or refuses to accept the prize, it will no longer be granted. The winner is deemed impossible to contact if he/she fails to respond to the announcement email, and act under the instructions in the email within 3 working days of sending date. The organizer will send 1 email.

If the winner refuses the prize offered in this campaign, he/she will sign a sworn statement that will state that he/she waives the prize and any other rights associated with it. If this statement cannot be signed at the Organizer's registered office or in the presence of a representative of the Organizer, the statement will be sent to the Organizer by registered letter or by courier.

The winner will take possession of the prize offered within 15 working days from the date of prize announcement. Total value of prize is approximately 1,400 Euro and will be offered in the form of a course in the School for Startups Romania 2012.

### **3. RIGHT TO PARTICIPATE**

The competition is open to all individuals entitled to residence in Romania, who until the beginning of the contest, namely November 7, 2011, have reached the age of 18. Employees of the Organizer, of partners, agencies and dealers involved in this competition, as well as their immediate relatives (children, parents, husband / wife, etc.) are not allowed to take part in this competition. The participant must have the same name as on the identity card or have some data that correspond to it (identity card) so as to be identified correctly.

If the winner is an individual who cannot exercise his full legal capacity, he/she is entitled to receive the prize through his legal guardian who will sign a declaration where the Organizer is released from any liability arising from granting the prize, as well as from the payment of any damages or claims of any kind relating to that prize.

Participation in this Contest requires full, explicit and unequivocal knowledge and acceptance of the Official Regulations.

### **4. COMPETITION MECHANISM**

To participate in this competition, participants must follow the following steps:

1. Be fans of the Facebook page School for Startups Romania (those who are not fans of this page will press like on the start banner)
2. During November 7, 2011 – January 2, 2012, participants can sign up their business idea under the competition tab on the School for Startups Romania Facebook page
3. In order to sign up their idea, participants have to press „Participate” button and fill in the form with personal information
4. January, 2 is the last day for participation in the competition
5. During January 2 and January 16 all applications will be gathered
  - A participant has the right to sign up in the competition only once. In the end, all applications registered through the competition considered valid will be taken into consideration.
  - The winner will be decided after careful review of all applications in the competition.
  - Participants’ Facebook accounts must be active (have posts, interactions) and a minimum of 25 friends. Persons who have accounts deemed fake by the Organiser will be disqualified.

6. January 16 – announcement of the winner on the official wall – the winner will receive free training within the entrepreneurial program School for Startups Romania 2012.

The organizer is not responsible for the fact that third parties may use information posted by the participants or made available in the media designated for the Competition. Moreover, participants assume full civil and criminal liability for information they transmit or publish. Participants are fully responsible for the content of images, texts and information they publish.

Participants agree and undertake not to use the services [www.facebook.com/s4sromania](http://www.facebook.com/s4sromania) so as to instigate the breach of Romanian legislation. At the same time, participants agree and undertake not to provide information to support illegal activity.
